



Guidelines for Validating Instructor Credentials to Teach

SACS Requirements and University Expectations

These guidelines apply to all instructional faculty, including graduate teaching assistants, who are instructors of record at Texas A&M University and its two branch campuses, Texas A&M University at Galveston, and Texas A&M University at Qatar.

In its Faculty Credentials Guidelines, the Southern Association of College and Schools Commission on Colleges (SACSCOC) provides the following guidance regarding qualifications of individuals serving as instructors of record:

“When an institution defines faculty qualifications using faculty credentials, institutions should use the following as credential guidelines:

- a) Faculty teaching general education courses at the undergraduate level: doctorate or master’s degree in the teaching discipline or master’s degree with a concentration in the teaching discipline (a minimum of 18 graduate semester hours in the teaching discipline).
- b) Faculty teaching associate degree courses designed for transfer to a baccalaureate degree: doctorate or master’s degree in the teaching discipline or master’s degree with a concentration in the teaching discipline (a minimum of 18 graduate semester hours in the teaching discipline).
- c) Faculty teaching associate degree courses not designed for transfer to the baccalaureate degree: bachelor’s degree in the teaching discipline, or associate’s degree and demonstrated competencies in the teaching discipline.
- d) Faculty teaching baccalaureate courses: doctorate or master’s degree in the teaching discipline or master’s degree with a concentration in the teaching discipline (minimum of 18 graduate semester hours in the teaching discipline).
- e) Faculty teaching graduate and post-baccalaureate course work: earned doctorate/terminal degree in the teaching discipline or a related discipline.
- f) Graduate teaching assistants: master’s in the teaching discipline or 18 graduate semester hours in the teaching discipline, direct supervision by a faculty member experienced in the teaching discipline, regular in-service training, and planned and periodic evaluations.”

SACSCOC standards on faculty qualifications also state:

“The institution also considers competence, effectiveness, and capacity, including, as appropriate, undergraduate and graduate degrees, related work experiences in the field, professional licensure and certifications, honors and awards, continuous documented excellence in teaching, or other demonstrated competencies and achievements that contribute to effective teaching and student learning outcomes.”

At Texas A&M University, its branch campuses in Galveston and Qatar and the McAllen Higher Education Center, the primary indicator used to determine instructors’ qualifications to teach is a terminal degree in the discipline of instruction. In some cases, faculty members are considered qualified for instruction based on factors other than an in-discipline terminal degree, such as:

- Terminal degree in a closely related field
- A master’s degree or at least 18 semester credit hours of graduate-level coursework in the same or a closely related field
- Professional licensure or certification in a related field or profession
- Significant professional, research, or teaching experience in the same or closely related field



If any of the bulleted items above apply, the department head is responsible for describing such qualifications for each instructor of record in the Faculty Affairs Portal. Note that length of time alone is not enough justification, and a detailed description of qualifications is needed. **The following general justifications are not acceptable: “Individual has a degree in the field.” or “Individual taught this course previously.”**

Semester-Based Credentialing Process

Department Heads are responsible for justifying the teaching qualifications for their faculty in the Faculty Affairs Portal. Departments/colleges/schools are responsible for overseeing the hiring of graduate assistants who serve as instructors of record. The Office of Faculty Affairs assumes responsibility for verifying the teaching qualifications for faculty.

On occasion faculty may serve as instructor of record for a course outside their home department/college/school. Please note, department heads only have access in the Faculty Affairs Portal to justify the teaching credentials of faculty in their own department. Therefore, the department head for the course will need to work with the faculty member’s home department head to justify the teaching credentials of the faculty member for the course.

Texas A&M University uses the federal Classification of Instructional Program (CIP) codes to determine whether an instructor’s educational background is in the same discipline as courses they teach. The CIP codes for courses are maintained in the Texas Higher Education Coordinating Board’s course inventory for Texas A&M University. The CIP code of each instructor’s highest earned degree is maintained in the Office of Faculty Affairs faculty database.

Prior to the first day of classes, the Faculty Affairs Portal compares the CIP code for each instructor’s earned degrees to the CIP code for course sections the instructor is assigned to teach. If degrees, master’s and/or doctoral depending on the course level being taught, and course CIP codes are not an exact match (first four digits), the department head must provide a detailed justification that relates the instructor’s education (including certificates) and professional experience to the course content in order to justify and document the instructor’s qualifications to teach each course. For any instructor of record justification entered by the department that is found to be insufficient, the Faculty Affairs Office will mark the justification as invalid in the Faculty Affairs Portal and provide feedback on what is needed. Once the justification is marked invalid, an automated email is sent out by the Faculty Affairs Portal notifying the department credentialing user(s) that they need to login to the Faculty Affairs Portal to make corrections.

Recommendations for Departments/Colleges/Schools

Instructor of Record Assignment: Instructor of Record course assignments must be completed through Compass by the department/college/school first in order for the course assignments to populate to the Faculty Affairs Portal. Course assignments filter from Compass to the Faculty Affairs Portal updating every night at midnight. Once assignments have been completed the department/college/school will need to check the Faculty Affairs Portal to determine if the instructor requires credentialing. Please note, there is a 24-hour lag time between assigning the instructor of record in Compass and the instructor showing up as needing to be credentialed in the Faculty Affairs Portal. **For questions about assigning Instructor of Records in Compass, contact Scheduling at (979) 458-4950 or scheduling@tamu.edu.**

Courses: Course CIP codes that correspond to the subject matter of that course are assigned by the department or unit administering the course, typically when the course is first proposed. CIP codes reflect the content of the course and not the department in which the course is offered.

Course CIP codes for all Texas A&M University programs are included in an inventory maintained by the Texas Higher Education Coordinating Board and may be downloaded from the Board’s data server at:

We recommend departments periodically review CIP codes assigned to their courses to ensure alignment between the CIP code, course content, and degree program. Administrative units wishing to change CIP codes assigned to courses already listed on the THECB inventory should contact the Office of the Registrar for information regarding the request and approval process.

New Faculty: At the time of hire in the Faculty Affairs Portal, administrative units (departments/colleges/schools) are required to complete credentialing information for the new faculty member: earned degrees (degrees are verified and transcripts requested), courses the individual is expected to teach, and the individual's qualifications to teach assigned courses (if the first four digits of the CIP code of the qualifying degrees do not match the first four digits of the courses' CIP codes). The process described above for Semester-Based Credentialing is the same process followed to credential new faculty members.

Graduate Students: To meet SACS guidelines, all graduate students assigned as instructors of record should have satisfactorily completed a master's degree in the discipline or related discipline or at least 18 semester-based graduate credit hours in the same or a closely related discipline to that of instruction. The Faculty Affairs Portal captures the current number of graduate credit hours completed by the student. The Office of Faculty Affairs verifies that the individual is teaching a course in the same program where they are getting their degree and for which they have completed 18 semester-based credit hours. Credits for which an "incomplete" has been assigned, such as research hours, should not be included in determining the number of graduate hours completed. Graduate student instructors of record should receive appropriate training prior to instruction. Training may include completion of the teaching assistant training provided by the Center for Teaching Excellence, auditing the course during the term prior to instruction, or in-department training. All graduate student instructors of record must be supervised by a faculty member holding teaching credentials appropriate to the course and should be regularly evaluated on their teaching performance. **For questions about graduate students serving as instructor of record, contact the Graduate and Professional School at grad@tamu.edu or (979) 845-3631.**

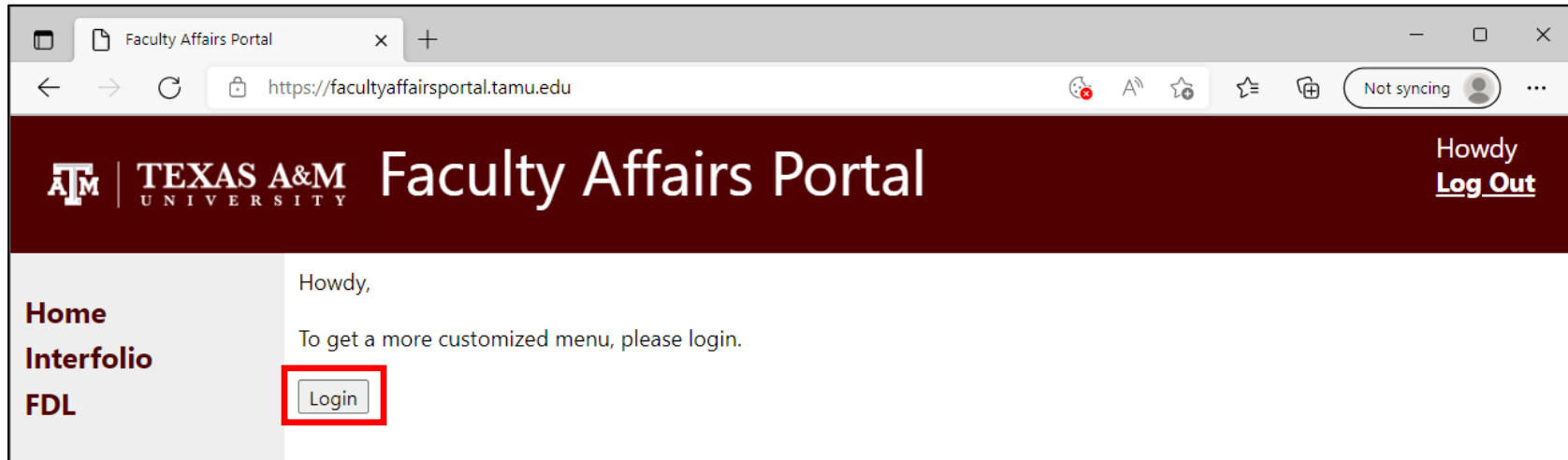

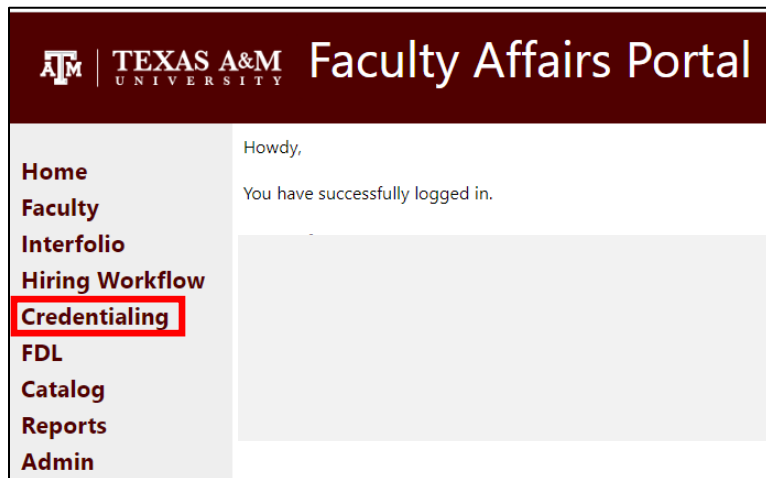

ATTACHMENT #1 - Faculty Affairs Portal Instructions for Credentialing


1. To credential Instructors of Record through the Faculty Affairs Portal, go to: <https://facultyaffairsportal.tamu.edu/>.
2. "Login" with your NetID & Password.



3. Select "Credentialing". If you do not see this option, please submit a signed [Faculty Affairs Portal Access Request Form](#) to facultyhiring@tamu.edu to request access.



4. Select "Courses By Term" to see a list of courses that need credentialing or still need an instructor assigned to it.

If the instructor does not have a terminal degree in the teaching discipline (first 4 digits of the CIP code of the terminal degree and the course being taught do not match), a detailed justification is required that relates the instructor’s education (including certificates) and professional experience to the course content in order to verify and document the instructor’s qualifications to teach each course. Note that length of time alone is not enough justification, and a detailed description of qualifications is needed. **The following general justifications are not acceptable: “Individual has a degree in the field.” or “Individual taught this course previously.”**

If additional justification is needed, click on “Add”.

The Justifications Section is also the section where the department should upload the instructor’s CV.

14. To add a Justification “Code”, select the appropriate code from the pull-down menu and enter the appropriate justification in the “Detail” box. After adding the required information click “Submit” and proceed with Justifying the Course with the below steps. (For a description of each code, see the Justifications Section).

15. **Courses Taught:** In the “Courses Taught” section will be a list of the courses being taught by the instructor. The list can be filtered by “All” or “Current Year and Future”. In the first column in the table the “Term Code” is listed. The “Term Code” is broken down as follows: YYYYSC --> Year = YYYY, Semester = S (1-Spring, 2-Summer, 3-Fall), and Campus = C (1-CS, 2-GV, 3-QT).

If the term “Justify” is listed for the course, that course will need to be justified by the department head. To do this, click “Justify”.
